HOLTER RENTAL AGREEMENT

Any reference to the Holter OWNER is referring to the Shiloh Shepherd Dog Club of America (SSDCA) c/o Michelle Schubring and/or Vanessa Dutton and any reference to the RENTER is referring to You, the undersigned.

TERMS AND CONDITIONS

All fees are in US funds and must be paid in advance of the rental. Payments made through PayPal will have the applicable PayPal fees added to the price.

Rental fee for use of the Holter for up to 10 days is \$100.00 for SSDCA members and \$110.00 for non-SSDCA members. Rental includes the use of the monitor, vest, case, strap, leads and one hook-up kit. Additional hook-up kits are available for \$5.00 each. Analysis of the recording by Alba Medical is included in the Rental fee.

The RENTER is responsible to pay all shipping fees and insurance fees to have the monitor shipped to the RENTER and when returning the monitor to the Holter OWNER. The Shipping and Insurance fees are included in the Rental fee and will vary and depend on where in the US or Canada the RENTER is located. The monitor is shipped from Virginia for use within the US and from Alberta for use within Canada. The monitor MUST be insured for the full price of \$1450.00.

The Rental term begins on the date the OWNER ships the equipment and ends on the date the OWNER receives the returned equipment. If the equipment is not returned to the OWNER by the end of the 10 day term, the additional days will be charged at the rate of \$5.00 per day to be paid upon return of the Holter to the Holter OWNER.

No allowance will be made for any rented equipment or portion thereof claimed as unused. Acceptance of returned equipment by the OWNER does not constitute a waiver of any of the rights the OWNER has under the rental agreement.

The vest, case and strap should be returned to the Holter OWNER clean and sticky-rolled for dog hair. Lead wires should be gently wiped clean of tape residue with alcohol wipes prior to return.

The RENTER has 24 hours upon receiving the Holter to assess the overall condition and notify the Holter OWNER of any issues. The RENTER is also responsible for the return of the Holter with Delivery Confirmation and the required Insurance to cover at least \$1450.00 in the event of loss/damage of equipment.

The RENTER will not remove the equipment from the address of the RENTER or the location shown herein as the place of use of the equipment without prior written approval of the OWNER. The RENTER will inform the OWNER upon request of the exact location and condition of the equipment while in the RENTER's possession.

As the RENTER, it is very important that your puppy be supervised constantly during the 24 hour period. Please DO NOT send the puppy unsupervised into your yard or leave the house with your pup home alone. You are not to allow your dog to wear the Holter and Holter vest outside if it is raining/snowing/hailing as this may cause damage to the Holter and additional expenses for you. It is also your responsibility to ensure the Holter is not damaged through contact with other animals.

The Holter Monitor is a piece of human grade medical equipment valued at \$1450.00. By requesting to rent this monitor from the OWNER, the RENTER takes on full responsibility for the condition of the Holter, Leads, and the Holter vest. Any damage to any of these items will be the responsibility of the RENTER. If the Holter is damaged, the replacement cost of the Holter is no less than \$1295.00, replacement cost of the Holter leads is no less than \$65.00, replacement of the Holter vest is no less than \$147.50 and replacement of the Holter case is no less than \$38.50. Applicable taxes and shipping charges will be added to the replacement cost. Extent of damage will be assessed by the Holter OWNER and relayed to the RENTER within 5 days of the return of the Holter.
